The CD-ROM included with the next edition of the book will include the text of the recently adopted Anticounterfeiting Trade Agreement. Recently added to the CD-ROM are the Rules of Practice of the U.S. Court of Appeals for the Federal Circuit. Those who practice before the court obviously need to be well-acquainted with these complex rules. The rules cover such issues as how to file an appeal, stays or injunctions pending appeal, motion practice, the preparation and filing of briefs, oral argument, citation practice, en banc determinations, and petitions for rehearing. The CD-ROM also includes information relevant to congressional consideration of patent law reform.
